#### (15) **Description**

The Temperature Sensor Assembly Thermo Electric Type XPS1 for temperature measurement, in different versions, consists of one or more inserts, a junction box or a connection head provided with terminals and optional extension parts.

The inserts consists of a metal sheathed mineral insulated cable available with various diameters and lengths, one or two thermocouple or RTD temperature sensing elements. The tip of the mineral insulated cable is closed by welding.

The other side of the mineral insulated cable is either

- provided with a potted transition part and a cable, available with various insulating materials, with or without braiding or
